Early Preterm (31 wks)/ (1.1 kg)/Extreme prematurity/ LSCS/male/Respiratory Distress Delivered at samarth hospital on 24/06/2026.

PRESENTING COMPLAINTS

Early Preterm (31 wks)/ (1.1 kg)/Extreme prematurity/ LSCS/male/Respiratory Distress, Baby cried immediately after birth but as baby had respiratory distress referred to us for further management and care.

EXAMINATION FINDING

O/E:

GC - Sick

Moderate respiratory distress

CVS : HR- 170 min S1 S2+ No murmur

Respi: RR-80 min B/l AE+ Moderate distress+ Tachypnea+ SCR++

P/A: Soft

CNS: Af at level .tone/cry/activity - poor

COURSE IN THE HOSPITAL

Baby came to us with above mentioned complaints.

Resp: Baby was started on HHHFNC support (1 L O₂ , 4L AIR), loading and maintenance of Inj Capnea started in view of 1 episode of apnea

CVS: S1 S2+ 2d echo was done which showed Small to moderate PDA (1.5mm) which was managed with (Inj PCM). Baby is normotensive during stay.

GIT: baby initially kept Npo & started with IV fluids i/v/o unsettled distress .As distress settled OG Feeds were started 1ml/6hrly which got hiked as per tolerance currently baby is on OG feed 6ml/2hrly, accepting well ,Baby is euglycemic during stay

CNS:Af at level .tone/cry/activity - poor which gradually improved

Sepsis: started on Inj Piptaz/ Inj Amika



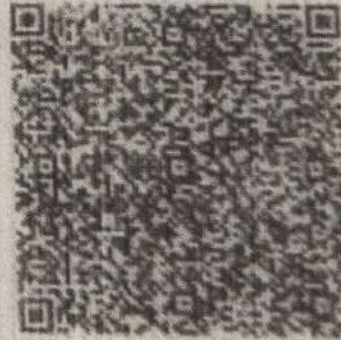

URGENT MEDICAL FUNDRAISING APPEAL

Help Save the Life of Baby of Shimpi Kumari (Twin Baby - Male)

Dear Kind Supporter,

We humbly seek your support for **Baby of Shimpi Kumari (Twin Baby - Male)**, who was born on **24 June 2026** as an **extremely premature baby at only 31 weeks of pregnancy**, weighing just **1.1 kg**.

Immediately after birth, the baby developed **severe respiratory distress** and had to be shifted to the NICU for specialized treatment. According to the treating doctors, the baby requires continuous medical monitoring and intensive neonatal care to survive and recover.

Medical Condition

The child has been diagnosed with:

- * Extreme Prematurity (31 Weeks)
- * Respiratory Distress Syndrome
- * High Risk of Infection requiring intravenous antibiotics
- * Very Low Birth Weight (1.1 kg)
- * Moderate Respiratory Distress requiring oxygen support

Continuous NICU Monitoring and Specialized Neonatal Care

Despite receiving emergency treatment, the baby still requires ongoing medical care, regular investigations, medicines, nutritional support, and close observation by neonatal specialists.

Estimated Cost of Treatment
